FOR YOUR SAFETY AND THE SAFETY OF YOUR HUNTING COMPANIONS, NO ALCOHOL OR DRUG CONSUMPION IS ALLOWED WHILE HUNTING OR SHOOTING. DUCK AND GOOSE HUNTING CAN BE PHYSICALLY DEMANDING. WE EXPECT YOU TO KNOW YOUR PHYSICAL LIMITATIONS.**

### **RELEASE AND WAIVER OF LIABILITY**

By my signature below I certify I am fully aware of the hazards involved in the sport of hunting and the hazards associated with a duck lease operation, and understand the necessary actions to assure hunter safety. In consideration of being permitted to participate in the sport of hunting and shooting conducted by Captain Randy's Guide Service, I am willing to assume these hazards and do recognize they can be dangerous to both life and limb.

In full recognition of the hazards involved, I hereby release, waive and discharge Captain Randy's Guide Service, including owners, employees, people with whom they may contract for services, all landowners, and any additional Releasees, from all liability to the undersigned, spouses, legal representatives, heirs, successors, and assigns, for any and all loss, claim, or damages resulting there from, on account of injury to me or my property, even injury resulting in death, while participating in the sport of hunting and shooting. This release and waiver is complete as it is my intent to hold harmless and indemnify all Releasees for any injury that might result while I am involved in the sport of hunting and shooting conducted by Captain Randy's Guide Service, or while on the lease premises.

The undersigned assumes full responsibility for the risk of bodily injury, death or property loss or damage due to the actions or inactions of Releasees. The undersigned agrees this release, waiver and indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the state of Louisiana.

BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THIS IS A WAIVER RELEASING CAPTAIN RANDY'S GUIDE SERVICE AND ALL RELEASEES FROM ALL LIABILITY FOR ANY AND ALL LOSSES, DAMAGES TO PROPERTY AND INJURIES THAT MAY OCCUR WHILE PARTICIPATING IN THE SPORT OF HUNTING AND SHOOTING.
